A: Paid Parking:

• Councillor Powers has assured on hold for 1 year so it can be looked at by new. Standing item we keep on agenda to confirm agreement with the City to discuss with new Councillor after fall election. New Councillor Matt Francis has spoken to staff and that understanding is no different. No timeline, but meeting with staff soon with options. Why they want to generate revenue to pay for repair and upgrades for the lot. Looing at ways to pay for the upgrades. In the meantime to no paid parking.

B: City of Hamilton: Councillor Matt Francis

• Re-Enactment of the Battle of Stoney Creek 1813: June 3-4, 2023. City hired consultant as city took seriously. Consultant looking at issues. Councilor Francis has confirmed area at King and Centennial for extra parking. Event all looks positive.

- update old Britannia Cleaners site no changes with application, owner working through site plan approval. Councillor Francis will share when ready and will take appropriate action at that time with regards to requirements like a public community meeting. Would be good to have community presence at public meeting and to make suggestions for what think is necessary. Until such time, all clean up and issues in hands of developer. Making it safer. People should not be able to vandalize or use as shelter. Request to have the BIA meet with developer before a public meeting. Developer has advised to City Economic Development that they would like to work with the BIA. Good community development a priority for BIA.
- update on the KSE/Second Street condo. No changes, nothing sent to the City.
- update RL Heslop school site by the city Plan for spring demolition with first phase 2023 to demolish then grass on top. 2024 find funding secure in next budget then can go through what to do, come up with a plan park is recommended with input of community. Suggestions to date trail in upper part, community garden (need volunteers), playground below. Really about community and what community wants.
- update on the Stoney Creek Arena Stoney Creek Arena will operate as an ice surface this winter season while options continue to be explored. Matt meeting with staff soon no decision being made. Rental for arena only 20/hrs per week low, to keep open need hours and useage. Pre-covid use was already declining. Long term look at what to do. Short term arena requires substantial repairs \$2.4M +. Exploring options to connect with Saltfleet arena both low useage. Wards 10 and 5 both don't want to lose public arenas. Building single arenas are becoming obsolute. Double arenas building more cost effective. Councilllors Beattie and Francis working on. Need funds to build and it takes 10 years to save.
- Stoney Creek floodplain review Jones Street Work still continues on options for floodproofing work in the Jones St area (possibly extensive and expensive). Not reviewed yet. No change. Councillor Francis to follow up. Construction concern.
- Electrical issues with street poles. Councillor Francis needs a quote to be submitted. Tracy able to locate previous electrician that did almost all of the work and has excellent knowledge of issues and what was installed. Stoney Creek will have one shot to get it done. Locke Street and Westdale got funding for it. One thing suggested to look at would be upgrading to accommodate for food trucks. \$2000 for lights going to Council. Once quote received ~\$20 000 then Councillor Francis will take to Council.
- Sign taken out by vehicle earlier today. Tina offered to bring sign inside for public safety. Tracy to follow up with Tina and City.
- Council approved BIA Board today. Congratulations and thank you to the new Board.
